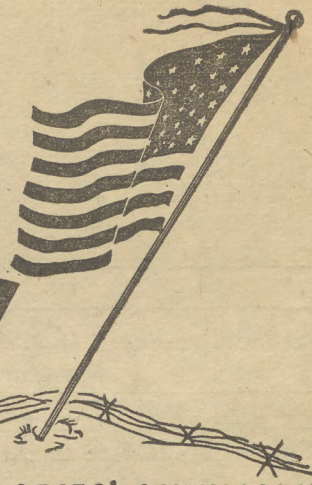

NCRAC Assails Red Anti-Semitism

Rockefeller Is Chairman Of JWV Dinner

NEW YORK, N. Y.—Nelson A. Rockefeller has been named chairman of a committee of leading business and civic leaders who will join with the Jewish War Veterans of the United States of America at the annual Gold Medal Award Dinner at the Waldorf-Astoria in New York.

The dinner will be held on Sunday evening, December 28 at 7:30 p. m.

Mr. Rockefeller's association with the dinner was announced by Colonel Harry D. Henshel, vice-president of the Bulova Watch Company and general.

Aiding Mr. Rockefeller in organizing the dinner program is a "kitchen cabinet" committee consisting of former associates of the New York Senator. The committee is headed by former Governor Charles Poletti and Kings County Judge Nathan Sobel while Walter T. Brown, executive secretary to Senator Lehman during his tenure as Governor of New York, is serving as secretary.

Others who are sponsoring the Award Dinner include: Mrs. Eleanor Roosevelt; Henry Morgenthau Jr., former Secretary of the Treasury; former Postmaster-General James A. Farley, chairman of the board of directors of the Coca-Cola Export Corporation; W. Averell Harriman, Mutual Security Administrator; and Samuel I. Rosenman, close friend and advisor to the late President Franklin D. Roosevelt.

Other distinguished officers of the dinner include: Samuel Rosenman, Chairman; Saul Gold, Treasurer; Ben Kaufman, C. M. H., Executive Director; and Leslie Levi, Chairman, National Finance Committee.

JWV members who will be unable to attend the dinner itself may obtain free tickets to the special section for non-diners, by writing to National Headquarters.

A-Spy Judge Praised By JWV Leader

Federal Judge Irving R. Kaufman has been praised by JWV for his "fair and judicial handling of the Rosenberg case throughout its course." The jurist was commended in a statement issued by JWV National Commander Jesse Moss who simultaneously denounced an organization calling itself the National Committee to Secure Justice for the Rosenbergs, which, he said, "has been waging a campaign of distortion designed to win clemency for the Rosenbergs on the wholly spurious theme

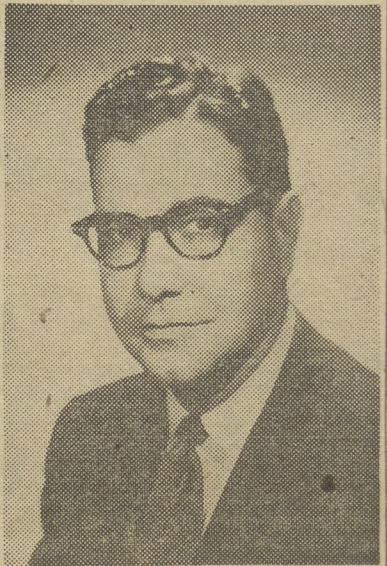

Let Red Goods Gather Dust

With the Christmas-Chanukah season again imminent, National Commander Jesse Moss has called upon Jewish War Veterans and other consumers to allow Soviet and satellite-manufactured prod-

ucts to gather dust on holiday shopping counters.

In a renewed appeal, Commander Moss pointed to the holiday shopping season as "a period during which purchasers should examine manufacturers' labels with special care to insure against a flow of U. S. dollars to Communist industry, which is feeding Communism's war against the United

States and her allies in Korea and Indo-China."

Ask Posts' Help

All JWV posts and departments have been asked to cooperate in the national campaign of consumer education, which is designed, according to Commander Moss, to induce consumers "to put their dollars to work for freedom

by buying only the goods and services of free labor and industry." The campaign, he emphasized, "is purely one of persuasion by education."

Almost all goods originating in Communist countries are currently on shop counters, Commander Moss pointed out. He issued the

European Survivor Of Nazi Horrors Tells—Why a JWV?

JWV members who work hardest at recruiting unanimously report that prospects always want to know, before anything else, why do we need an organization composed exclusively of Jewish veterans? We think that that question is dealt with most effectively and thoroughly in a recent story in the December issue of "JWViews," publication of the Sandy Weisberger-Leon Kaplan Post 165, of Scranton, Pa. The story was written by a veteran of the Nazi horrors.

During one of the monthly meetings of our post, a veteran mentioned that we go on record to pro-

test the issue of a re-entering permit to Fritz Kuhn, former notorious German-American Bund leader. The motion was carried and together with several other JWV posts recommendations forwarded to National Headquarters, all of which proved instrumental in barring this Nazi from the USA.

Miracle of Democracy

This procedure is a common and logical one, but to this writer who has lived the greater part in Europe, it is a revelation as well as the miracle of Democracy in action. This one procedure would be reason enough to sell JWV. In my talks with prominent people I hear very often that denominational veterans group is not warranted. Some are actually em-

An attack on the Jewish War Veterans by the Moscow Literary Gazette was characterized by National Commander Jesse Moss as "final proof that Russia has adopted an official policy of anti-Semitism and is dictating this policy to the Communist slave states."

The Russian publication had described JWV in a special diatribe as an "ultra-reactionary American organization." It assailed PNC Paul Ginsberg and a former national commander of the American Legion, Earle Cocke, Jr., as "inveterate warmongers."

These attacks, Commander Moss asserted, "make it plain that official Russian policy, rather than the will of the people of Czechoslovakia, was the governing factor in turning the trial of Czech Communists who had fallen from grace into a wholesale propaganda drive against the United States and Israel."

Russia's intentions, he said, "is to drum up anti-Semitism and anti-democratic feeling to gain her objectives in the Middle East and Germany."

He attributed the abuse di-

JWV, Other Groups Blast Czech Trial

The Jewish War Veterans, along with representatives of the other organizations which make up the National Community Relations Advisory Council, has assailed the Communist governments of Eastern Europe for having "launched upon the stimulation of anti-Semitism as a propaganda technique for defending and justifying their regimes and as a means of diverting their enslaved peoples from the contemplation of their slavery."

The statement was issued in connection with the recent purge trial in Czechoslovakia, where eleven defendants, most of them Jewish, were sentenced to death as members of a British-American-Israeli "conspiracy."

The statement was signed by Israel Goldstein, president of the American Jewish Congress; Adolph Held, chairman, Jewish Labor Committee; Jesse Moss, national commander of the Jewish War Veterans of the U. S. A.; Maurice W. Eisendrath, president, Union of American Hebrew Congregations; Simon G. Kramer, president of the Synagogue Council of America; and Irving Kane, chairman of the NCRAC.

Text of Statement

The full text of the statement follows:

The "show trial" just completed in Czechoslovakia is clear evidence that the Communist Eastern European governments have launched upon the stimulation of anti-Semitism as a propaganda technique for defending and justifying their regimes and as a means of diverting their enslaved peoples from the contemplation of their slavery. Whether or not the trials presage a policy of government oppression by the Red regimes against their Jewish populations as Jews, it already has become evident, from the conduct of the trials and the manner of their reporting in the controlled Communist press, that the Red governments—like all previous dictatorships—have had to resort to scapegoats to keep the minds of their subjects from brooding over a shortage of bread and a lack of freedom.

Jews Made Scapegoats

In choosing the Jews within their own countries as the scapegoats upon which their people are encouraged to vent the antagonisms engendered by their oppressive methods of government, the Moscow-dominated totalitarians have given final and incontrovertible evidence that their vaunted concern for the protection of minorities is as empty and cynical a claim as any other contrived by their propagandists.

The Communist authors of so many forms of terror and falsehood have at last openly revealed
